WHEREAS it has been discussed and determined that circumstances due to catastrophic events, such as a fire happen and that homeowners may not be able to live in their homes during repairs; and

WHEREAS it has also been discussed and determined that people who may need services turned off for an extended period of time (i.e. more than a month); and

WHEREAS those residents in these circumstances still would have to pay for services even if they are not used;

THEREFORE, BE IT ORDAINED that changes to section 25-22 (water connection required) and section 25-34 (suspension of services) of the Water Ordinance; section 18-15 (discontinued services) of the sewer ordinance and section 12-89 (fees) of the solid waste ordinance, as described in the attached document shall be enforced in conjunction with the aforementioned needs and events and made retroactive to March 1, 2020.

NOW THEREFORE BE IT ORDAINED that all other regulations in these ordinances shall remain in effect.

This amendment was adopted by the town council of the Town of Iron Gate on June 25, 2020.

IRON GATE - UTILITIES ORDINANCES as amended 5/27/20

WATER

Section 25-22 - Water connection required.

No person, having an interest in a house or other building located within two hundred fifty (250) feet of a public water main, shall use or allow such to be used as a human habitation or for any business or other purpose, or occupy or lease such for occupancy, until such house or building shall have first received a water tap and meter.

No person, being the owner of a house or other building being used for residential purposes, or is renting or leasing that building for residential use, shall be allowed to use that building until having first connected the plumbing of such with the Town of Iron Gate water system in order to insure the health and safety of persons therein.

Section 25-34 - Suspension of Services.

(b) If a property owner wishes to discontinue services for any reason, the owner must notify the Town Clerk in writing of the date of discontinuance and a date, if known, of reconnection. The owner will be responsible for all past due charges accrued at the time of disconnection and must pay the reconnection fee before service will be restored. The reconnection fee may be waived by the Town Clerk if the property owner can demonstrate extenuating circumstances requiring the disconnection.

SEWER

Section 18-15 - Discontinued Services.

It shall be unlawful for any owner, lessee or tenant whose water services has been discontinued to discharge, empty or dump, or cause to be discharged, emptied or dumped, any domestic sewage or industrial waste into the Town sewer system or sewage disposal works. Any owner, lessee or tenant violating the provision of this paragraph shall, upon conviction thereof, be fined not less than one hundred dollars (\$100). Each day's continuance of such violation shall constitute a separate offense. Such conviction shall not relieve any such owner, lessee or tenant from the payment of the sewage disposal service charges imposed by the provision of this ordinance.

SOLID WASTE

Section 12-89 - Fees.

The following charges will be placed on the monthly utility bill and will be due by the 21st day of the billing month, or the next business day if the 21st falls on a weekend or holiday. If not paid by this date a 10% penalty will be added. If water service has been discontinued at the address, all solid waste services will also be discontinued.

WHEREAS, the localities in the Alleghany Highlands have jointly prepared a major amendment to the regional Solid Waste Management Plan to address required updates and to address changes in the projected lifespan of Peters Mountain Landfill in the City of Covington;

WHEREAS, the Town of Iron Gate has held an advertised public hearing on February 25, 2010 regarding that plan now;

THEREFORE BE IT RESOLVED, THAT THE Town Council of Iron Gate does hereby adopt the 2010 Amendment to the "Solid Waste Management for the Alleghany Highlands," which includes Alleghany County, the City of Covington and the Town of Iron Gate and Clifton Forge, and authorizes the Mayor to implement the plan through coordination with said localities.

Introduction

The Alleghany Highlands Solid Waste Planning Unit includes the County of Alleghany, City of Covington, and the Towns of Clifton Forge and Iron Gate. The regional planning unit was formed in 1991 and developed its initial regional solid waste management plan. The regional unit was formed mainly for the reason that the localities involved utilized a common, regional landfill facility (Peters Mountain Landfill).

Many changes have occurred in the Highlands region since 1991 and since the last plan update in 2004. Several localities chose not to renew their contracts with the regional landfill in the late 90's. Only the City of Covington presently utilizes the landfill. By 2004, it was thought that the City would likely close the landfill but due to reduced waste consumption rates in the Highlands region, the cells that are presently open have had longer than originally anticipated and there are plans to expand the landfill (expansion is previously permitted) to meet future waste generation demand in the City of Covington. Continuing to plan for solid waste management in a regional fashion still, however, makes sense in the Highlands area. The Alleghany County Transfer Station (Island Ford Transfer Station) off of Valley Ridge Road currently serves three of the four localities in the planning unit (Alleghany County and the Towns of Clifton Forge and Iron Gate). All four localities in the solid waste planning unit currently utilize the resources and services of the Jackson River Enterprises (JRE) organization through contract to conduct all recycling and recycling education efforts.

The Roanoke Valley – Alleghany Regional Commission has compiled this amendment including updated data and waste projections to integrate into copies of the adopted Solid Waste Management Plan for the Alleghany Highlands (2004), per Solid Waste Management Plan 5-Year Update Guidance issued in April 2009 by the Virginia Department of Environmental Quality. The majority of the material in the 2004 plan update is still relevant with the exception of waste generation projections and the plans for future disposal activity in the City of Covington.

Section 9 VAC 20-130-120.C of the solid waste management planning regulations list the following items as necessary to consider and report in the update certification:

- 1. Waste generation estimates are current, both in quantities generated and in terms of composition.
- 2. The scheduled 20-year planning increments have been met.
- 3. The projected 20-year waste management capacity remains available or the projects designed to meet the required capacity are on schedule.

The following pages address these required updates and also planned changes in the capacity of Peters Mountain Landfill, a landfill facility currently used by the City of Covington.

Waste Disposal Facilities in the Alleghany Highlands

Forge, and Iron Gate is taken to the Waste collected in Alleghany County, Clifton Alleghany County Transfer Statio n located off of Valley Ridge Road in Alleghany County. Alleghany County conducts overall adm inistration of the facility and acts as the agent and overseer of daily operations. The transfer stat ion accepts all household waste, white goods, yard waste, construction debris, tires (an extra fee is charged), demolition waste, used antifreeze, used motor oil, brush, alum inum, cardboard, and lead acid batteries. St umps are not accepted at the transfer station. Records of the waste deliver ed by generator or collection com pany and the weight of the vehicle entering and leaving the faci lity are kept at the station. Records for the transfer station from Calendar Year 2008 show that the station received 68.82 tons per day of entire year. Of that am ount, municipal solid waste to reac h a total of 25,120.43 tons for the the Town of Clifton Forge Refuse collected by trucks se rving both Alleghany County and ounty residents, schools, and governm ental departm ents contributed 35.7%, Alleghany C contributed another 17.3%, the Town of Iron Gate contribu ted .75%, and the Virgini Department of Transportation contributed .69%. Contractors were billed for 11,000.12 tons or roughly 43.8% of the waste received at the transf er station. The T ransfer Station transferred 14,662.03 tons of waste in 2008 and recycled 10,485.40 t ons of waste made up of metal, brush, clean fill, and water.

The Alleghany County Transfer St ation currently imposes a fee of \$65 per ton for waste privately delivered by contractors from Alleghany County with a m inimum charge of \$15 and charges \$70 a ton for waste privately delivered by contractors from the other localities in the Highlands with a m inimum charge of \$25. Wast e delivered to the Al leghany County Transfer Station is s hipped v ia truck to US A W aste of Amelia, w hich d isposes of the waste in the Maplewood Landfill in Amelia County, VA. The cost of transferring and transporting the waste from the Transfer Station to the landfill in Amelia County is estimated at \$1,291,599 for fiscal year 2010. The Alleghany County Transfer Station Annual Report for Calendar Year 2008 can be found in the Attachments section of this amendment.

Citizens wishing to drop off waste item s at the transfer station should note the facility's hours of operation. The Alleghany County Transf er Station is open 9 AM to 5 PM Monday through Friday and is open from 8 AM until noo n on Saturday. Operators of the facility check all loads for hazardous or unacceptable wastes and will refuse unacceptable loads. Materials that are not accepted at the transfer station are the following: free liquids, regulated hazardous waste, contaminated soils, sludges, pesticide containers , waste oil, paint cans or drum s that are not empty, stumps or brush larger th an 8" in diameter, spoiled grain, gas tanks, manure, and septic sludge.

Waste collected in the City of C ovington is currently taken to the Peters Mountain Landfill. The City of Covington conducts overall administration of the facility and serves as the agent and overseer of daily landfill operations . Currently, the landfill accepts all household waste, white goods, yard waste, construction debris, tires, sludge and approved industrial wastes.

Stumps and waste oil are not accepted at the landfill at this time. Records of the waste delivered by generator or collection company and the weight of the vehicle entering and leaving the facility are kept at the landfill. Landfill records for the Calendar Year 2008 show that the landfill receives approximately 27.79 tons per day of municipal solid waste for a total of 10,146.94 tons received for the entire year. The landfill currently imposes a fee of \$65 per ton for all commercial waste privately delivered with a minimum charge of \$25. The latest Peters Mountain Landfill Annual Report can be found in the Attachments section of this amendment.

Citizens wishing to drop off waste items at the landfill should not the facility's hours of operation. The Peters Mountain L andfill is open 8 AM to 4 PM Mond ay through Friday and is closed on the weekends. Operators of the facility check all loads for hazardous or un acceptable wastes and will refuse unacceptable loads. Materials that <u>are not</u> accepted at the landfill are the following: free liquids, contam inated soils, pestic ide containers, waste oil, paint cans or drum s that are not empty, gas tanks, and any other regulated hazardous wastes.

New regulations were passed in 1991 for sanitary landfills. The Peters Mountain Landfill was granted a vertical extension which was utilized until closed in 2000. Closure cost for this cell was \$660,000. The City of Covington has been utilizing Cell A, a Subtitle D double-lined facility, since 2000 with an anticipated closure date of 2011. The estimated total cost for closure of this facility is \$2,396,255. Post-closure care is estimated at \$101,837 per year for both cells at the Peters Mountain L andfill. Cell B has been c onstructed and should provide an estim ated 5-7 years of life. Cells C & D are permitted, but not yet constructed. Together these cells should provide a minimum lifespan of 14 years. The City plans to utilize existing cells and permitted expansion of the Peters Mountain L andfill facility for its m unicipal solid waste dis posal needs through the 20 year planning horizon of this document.

This update to the waste generation projections contained in the 2004 plan was computed utilizing the same methodology. Per capita waste generation is expected to remain basically flat in the Highlands region and, therefore, overall waste generation should decline as the population is projected to decline through the planning horizon.

20-Year Plan Implementation Milestones

The 20-year solid waste management plan implementation milestones to be carried out by the localities in the Alle ghany Highlands and all actions taken since the last plan update to meet original objectives are listed below. Approximate cost figures for some of the strategies are also listed. The fact that population projections show a continued decline in the region's population combined with the fact that the region exceeds the mandated recycling rate requirements set by the state indicate that little needs to be done to augment existing efforts aim ed at ensuring that the recycling rate is met each year.

- 1. Local governments in the Highlands region have maintained the contract with Jackson River Enterprises for purposes of recycling.
- 2. The construction of Jackson River Enterprise 's new facility near the Applied Extrusion Technologies plant alleviated the burdens on the original collection and storage facilities for recyclables, thus fulfilling the original milestone calling for the provision of more storage space for recyclable materials.
- 3. Responsibility for all drop-off centers for r ecyclable materials was assumed by the local governments and all equipment given to Jacks on River Enterprises, thus fulfilling the original strategy calling for the assumption of responsibility for these locations. Locations of recyclable drop-offs are coordinated with Jackson River Enterprises.
- 4. The Highlands governments hired a recycling coordinator but decided that the administration of Jacks on River Enterprises better fills that rolle, thus fulfilling the strategy calling for the recruitment of a regional recycling coordinator.
- 5. The localities approved and adopted the newly revised Alleghany Highlands Solid W aste Management Plan in June 2004 thus meeting one of the milestones from the 2004 plan. Approval and adoption of this amendment will fulfill state regulations requiring updates every fifth year for solid waste management plans.
- 6. Some of the comprehensive plans of the region already reflect the goals, objectives, and recommendations from the original solid waste management planning efforts. The local governments of the Highlands should continue to consider ways to a mend local comprehensive plans, zoning ordinances and su bdivision ordinances to reflect the goals, objectives and recommendations discussed in this plan.
- 7. The construction of the new Jackson River Enterprises f acility provided the Highland's region with a perm anent site for recyclable materials, thus fulfilling another one of the original plan's objectives.
- 8. Continue to adopt ordinances (such as those requiring source reduction, business waste reporting, etc.) as needed to implement a successful solid wastern anagement program (ongoing as determined by need).

9. The localities of the Alleghany Highlands reg ion will amend this plan with a major amendment, as defined in the solid wast e management regulations 9 VAC 20-130-175, if any of the following changes to the current solid waste management program occur: addition, deletion, or cessation of operation of any solid wast e facility; any increase in landfill capacity; any change that moves toward implementation of a waste management strategy that is lower in the waste management hierarchy; and any change to membership in the approved area. The loc alities of the Alle ghany Highlands reg ion will am end the plan with a minor amendment if any of the following changes to the current solid waste management program occur: any change that moves toward implementation of a waste management strategy that is higher in the waste management hierarchy and any nonsubstantive administrative change such as change in name.

The 2010 amendment is a major amendment being made to reflect the desire of the City of Covington to expand the Peters Mountai n Landfill facility with the previously permitted Cells C & D to provide additional landfill capacity to the City of Covington.

- 10. The goal related to the expansion of drop-o ff centers for the regional recycling progra m has been met. Jackson River Enterprises currently makes regularly scheduled pickups from 10 drop-off centers for recyclable materials.
- 11. Continue annual or sem i-annual Highlands Re gional Tire A mnesty Days (tire collection events), as funding warrants.
- 12. Continue to develop information campaign for educating citizens about recycling, source reduction and reuse. Specifically, H ighlands localities should cooperate with the efforts of Jackson River Enterprises in this regard (production of informational brochures on recycling and the conduct of informational tours through the recycling facilities).
- 13. The City of Covington has elected to continue utilizing permitted expansion available at the Peters Mountain L and fill facility thus fullfilling the implementation milestone from the 2004 plan calling for the City to study alternatives and prepare a plan of action well in advance of the current cell's closure.
- 14. The strategy involving school-wide solid waste education program s has been m et. Jackson River Enterprises provides schools in the region with educat ional tours of their recycling facility.
- 15. Develop a Highlands regiona 1 collection program for hous ehold hazardous waste (FY 2010-13 and continuing as is feasible).

¹ Major amendments require a public participation process before submission to the Department of Environmental Quality. This process is required to include a public hearing preceded by a published notice. Records of the hearing along with a copy of all written comments and the submitter's response to all comments received must be submitted with a major amendment. Minor amendments do not require a public participation process and must be submitted directly to the Department of Environmental Quality for approval.

Alleghany School Board brought in 44 loads totaling 39.64 tons

Greenthumb brought in \$6 loads, at 3.32 tons.

Build a Better Future brought in 38 loads, totaling 11.17 tons.

County Owned Properties brought in 7 loads, totaling 1.05 tons

I.F.T.S. transferred 14,662.03 tons of solid waste, totaling 738 tractor trailer loads averaging 19.87 tons per load, to USA Waste of Amilia,

I F T.S. received 25,120.43 tons of waste and land filled 14,662.03 tons, therefore we recycled 60,458.40 tons of metal, brush, clean fill, and water.

A RESOLUTION APPROVING A MAJOR AMENDMENT TO THE SOLID WASTE MANAGEMENT PLAN FOR THE ALLEGHANY HIGHLANDS REGION IN VIRGINIA

WHEREAS, Alleghany County, the City of Covington, and the Towns of iron Gate and Clifton Forge are local governments for the residents living within the boundaries of the Alleghany Highlands;

WHEREAS, the Virginia Waste Management Board has adopted regulations which require each county, city and town in the Commonwealth to submit a revised solid waste management plan to the Department of Environmental Quality in the event that there is an addition, deletion, or cessation or operation of any solids waste facility, any increase in landfill capacity, any change that moves toward implementation of a waste management strategy that is lower in the waste management hierarchy, and any change to membership in the approved area;

WHEREAS, the localities in the Alleghany Highlands have jointly prepared a major amendment to the regional Solid Waste Management Plan to address the change in service area which will add Bath County as a customer of Peters Mountain Landfill;

WHEREAS, the Town of Iron Gate has held an advertised public hearing on June 24, 2014 regarding that plan, now; and

THEREFORE BE IT RESOLVED, that the Town Council of Iron Gate does hereby adopt the 2014 Amendment to the "Solid Waste Management for the Alleghany Highlands," which includes Alleghany County, the City of Covington, and the Town of Iron Gate, and authorizes the Mayor to implement the plan through coordination with said localities.



SOLID WASTE MANAGEMENT PLAN FOR THE ALLEGHANY HIGHLANDS

2014 Amendment



This document was prepared by the staff CHA Consulting, Inc and was funded by the City of Covington, VA.

Introduction

The Alleghany Highlands Solid Waste Planning Unit includes the County of Alleghany, City of Covington, and the Towns of Clifton Forge and Iron Gate. The regional planning unit was formed in 1991 and developed its initial regional solid waste management plan. The regional unit was formed mainly for the reason that the localities involved utilized a common, regional landfill facility (Peters Mountain Landfill).

Many changes have occurred in the Highlands region between 1991 and 2010. Several localities chose not to renew their contracts with the regional landfill in the late 90's. By 2004, it was thought that the City would likely close the landfill but due to reduced waste consumption rates in the Highlands region, the cells that are presently open have had longer than anticipated lifespans and there are plans to expand the landfill (expansion is previously permitted) to meet future waste generation demand in the City of Covington. Continuing to plan for solid waste management in a regional fashion still, however, makes sense in the Highlands area. Only the City of Covington utilized Peters Mountain Landfill until July 1, 2014 when Bath County signed a contract to start delivering waste to the landfill as a customer of the City of Covington. The Alleghany County Transfer Station (Island Ford Transfer Station) off of Valley Ridge Road currently serves three of the four localities in the planning unit (Alleghany County and the Towns of Clifton Forge and Iron Gate). All four localities in the solid waste planning unit currently utilize the resources and services of the Jackson River Enterprises (JRE) organization through contract to conduct all recycling and recycling education efforts.

CHA Consulting, Inc has compiled this amendment to integrate into copies of the adopted Solid Waste Management Plan for the Alleghany Highlands (2010), per Section 9VAC 20-130-175 of the solid waste management planning regulations. All material in the 2010 plan update is still relevant. A copy of the resolution adopted by each Highlands local government, signifying their approval of this solid waste plan, is included as an Attachment.

Section 9 VAC 20-130-175 of the solid waste management planning regulations list the following items as necessary to consider and report in the update certification:

- 1. Addition, deletion, or cessation of operation of any solid waste facility;
- 2. any increase in landfill capacity;
- 3. any change that moves toward implementation of a waste management strategy that is lower in the waste management hierarchy; and
- 4. any change to membership in the approved area.

The following pages address the additional required updates in response to the expanded service area of Peters Mountain Landfill. It is not anticipated that the addition of Bath County waste to the Peters Mountain Landfill will cause the landfill to exceed the daily maximum tonnage (51 tons/day). Therefore, it is not anticipated that there will be any changed in the life expectancy of the landfill.

Consideration of the Waste Management Hierarchy in the Alleghany Highlands

Landfill

A sanitary landfill is an engineered facility for the disposal of solid waste which is so located, designed, constructed, and operated to contain and isolate the solid waste so that it does not pose a substantial hazard to human health or the environment presently or in the future.

The region utilizes two separate facilities that fit under this category in the solid waste management hierarchy: the Peters Mountain Landfill and the Alleghany County Transfer Station.

The new cells of the Peters Mountain Landfill (double-lined cells utilized since the closure of the vertical extension in 2000) are currently being utilized by the City of Covington for waste disposal purposes with Bath County as a customer of the Landfill. For more Information regarding the Post-closure care for the Peters Mountain Landfill, see "Waste Disposal Facilities in the Alleghany Highlands."

The Alleghany County Transfer Station is the other major facility that falls under the Landfill category in the solid waste management hierarchy. Waste collected here is transported to the Maplewood facility in Amelia County. It should be noted here, however, that the localities in the Highlands have made it one of their objectives to continually search out the most economical and environmentally sound method of solid waste management and this may involve a switch to a different 'destination landfill' in the future.

Existing Waste Management Programs in the Alleghany Highlands

Waste Disposal Facilities in the Alleghany Highlands

Waste collected in Alleghany County, Clifton Forge, and Iron Gate is taken to the Alleghany County Transfer Station located off of Valley Ridge Road in Alleghany County. Alleghany County conducts overall administration of the facility and acts as the agent and overseer of daily operations. The transfer station accepts all household waste, white goods, yard waste, construction debris, tires (an extra fee is charged), demolition waste, used antifreeze, used motor oil, brush, aluminum, cardboard, and lead acid batteries. Stumps are not accepted at the transfer station. Records of the waste delivered by generator or collection company and the weight of the vehicle entering and leaving the facility are kept at the station. Records for the transfer station from Calendar Year 2008 show that the station received 68.82 tons per day of municipal solid waste to reach a total of 25,120.43 tons for the entire year. Of that amount, Refuse collected by trucks serving both Alleghany County and the Town of Clifton Forge contributed 35.7%, Alleghany County residents, schools, and governmental departments contributed another 17.3%, the Town of Iron Gate contributed 0.75%, and the Virginia Department of Transportation contributed 0.69%. Contractors were billed for 11,000.12 tons or roughly 43.8% of the waste received at the transfer station. The Transfer Station transferred 14,662.03 tons of waste in 2008 and recycled 10,485.40 tons of waste made up of metal, brush, clean fill, and water.

The Alleghany County Transfer Station currently imposes a fee of \$65 per ton for waste privately delivered by contractors from Alleghany County with a minimum charge of \$15 and charges \$70 a ton for waste privately delivered by contractors from the other localities in the Highlands with a minimum charge of \$25. Waste delivered to the Alleghany County Transfer Station is shipped via truck to USA Waste of Amelia, which disposes of the waste in the Maplewood Landfill in Amelia County, VA. The cost of transferring and transporting the waste from the Transfer Station to the landfill in Amelia County is estimated at \$1,291,599 for fiscal year 2010. The Alleghany County Transfer Station Annual Report for Calendar Year 2008 can be found in the Attachments section of the 2010 amendment.

Citizens wishing to drop off waste items at the transfer station should note the facility's hours of operation. The Alleghany County Transfer Station is open 9 AM to 5 PM Monday through Friday and is open from 8 AM until noon on Saturday. Operators of the facility check all loads for hazardous or unacceptable wastes and will refuse unacceptable loads. Materials that **are not** accepted at the transfer station are the following: free liquids, regulated hazardous waste, contaminated soils, sludges, pesticide containers, waste oil, paint cans or drums that are not empty, stumps or brush larger than 8" in diameter, spoiled grain, gas tanks, manure, and septic sludge.

Waste collected in the City of Covington and Bath County is currently taken to the Peters Mountain Landfill. Bath County is responsible for the collection and hauling of waste to the landfill. The City of Covington conducts overall administration of the facility and serves as the agent and overseer of daily landfill operations. Currently, the landfill accepts all household waste, white goods, yard waste, construction debris, tires, sludge and approved industrial wastes. Stumps and waste oil are not accepted at the landfill at this time. Records of the waste delivered by generator or collection company and the weight of the vehicle entering and leaving the facility are kept at the landfill. Landfill records for the Calendar Year 2008 show that the landfill receives approximately 27.79 tons per day of municipal solid waste for a total of 10,146.94 tons received for the entire year. With the addition of Bath County to the service area, it is anticipated that the daily maximum tonnage will remain below 51 tons/day. The landfill currently imposes a fee of \$75 per ton for all commercial waste privately delivered with a minimum charge of \$25. Bath County has negotiated a \$40 per fee ton to use the Peters Mountain Landfill. The latest Peters Mountain Landfill Annual Report can be found in the Attachments section of the 2010 amendment.

Citizens wishing to drop off waste items at the landfill should note the facility's hours of operation. The Peters Mountain Landfill is open 8 AM to 4 PM Monday through Friday and is closed on the weekends. Operators of the facility check all loads for hazardous or unacceptable wastes and will refuse unacceptable loads. Materials that <u>are not</u> accepted at the landfill are the following: free liquids, contaminated soils, pesticide containers, waste oil, paint cans or drums that are not empty, gas tanks, and any other regulated hazardous wastes.

New regulations were passed in 1991 for sanitary landfills. The Peters Mountain Landfill was granted a vertical extension which was utilized until closed in 2000. Closure cost for this cell was \$660,000. The City of Covington has been utilizing Cell A, a Subtitle D double-lined

facility, since 2000 with an anticipated closure date of 2011. The estimated total cost for closure of this facility is \$2,396,255. Post-closure care is estimated at \$101,837 per year for both cells at the Peters Mountain Landfill. Cell B has been constructed and should provide an estimated 5-7 years of life. Cells C & D are permitted, but not yet constructed. Together these cells should provide a minimum lifespan of 14 years. The City plans to utilize existing cells and permitted expansion of the Peters Mountain Landfill facility for its municipal solid waste disposal needs through the 20 year planning horizon of this document.
